**Eligibility:** A pass in Class 12 (10+2)/ PUC or equivalent with a minimum of 45% marks at the final examination is the minimum eligibility for appearing for SLCU Law Entrance Examination. The candidates should also be below the age of 20 years as on July 01, 2010.

Candidates must note that if selected, admission is provisional and subject to University rules - Any documents that are pending to be submitted to Office of Admissions, Christ University, should be submitted on or before July 15, 2010. Failing to submit the pending documents will be treated as unsuccessful in the qualifying exam and admission will be terminated from Christ University.

## 4. Course Structure

#### General outline:

The School of Law follows a semester system having 2 semesters in a year. The Students will complete 53 subjects which include 20 compulsory law subjects and 8 Honours subjects. These courses normally comprise of 24-30 lecture hours spread over a week for 20 weeks per subject. The students are engaged

in the remaining hours, i.e. 12-18, in learning of different skills that are essential for the profession.

All the papers normally carry 4 credits, which means four class hours of one hour duration each and one hour moot court/project work/tutorial per week; the 20 compulsory law subjects and the honors papers on the other hand would carry 5 credits each.

The non-law papers consist of one major subject with 6 papers in the discipline of Political Science, and two minor subjects, 3 of history and 3 of sociology with one paper of English language/communicative English.

The compulsory Law papers include 4 long papers with 5 plus 5 plus credits in Constitutional Law, Labour Law, Family Law and Law of Contract; and 8 honors papers with 5 credits each for the purpose of specialization. The remaining papers such as the optional courses, clinical subjects, carry 4 credits each.

All the papers and course outline have been prepared to incorporate the Bar Council of India Rules of Legal Education 2008, and a few more papers have been added with a view to impart the four type of skills mentioned above.

#### (i) BA LLB

The main objective of this course is to provide in-depth knowledge in professional law courses with the four types of skills mentioned above. Since, rule of law is the cornerstone of the constitutional governance these courses of study would also focus on the public policy, both of the Central Government and the State Governments out of which flows the specific laws.

The non-law major subject with 6 papers, introduced here is therefore in the discipline of Political Science, one minor subject with three papers in Economics, and another minor subject with 3 papers is English Language. Since one of the minor subjects chosen is English language, teaching of another paper on English Language as compulsory subject is not introduced in this School of Law.

## 5. Faculty

The current faculty is comprised of teachers from some of the best universities and law schools and having years of experience in teaching and practicing law. #### 6. Extra curricular and Co-curricular activities

Students of School of Law have made their presence felt at national and international moot court and client counseling competitions. The current faculty has experience both in terms of participating in National and International Moot Court Competitions and training students to compete at these events and also judging international moot court competitions. We have successfully organized the national round of 'The Commonwealth Moot Court Competition, 2009' and teams from 22 institutions participated. We have hosted training programs, national disarmament seminar and national nuclear disarmament workshop.

#### 7. Associations and Fest

School of Law, Christ University has a number of associations that cater to the varied interests of the student community. Apart from Moot Courts and Client Counseling events, we have associations for literary, debate, cultural, sports, legal literacy, journal and dramatics to promote students' potentials. The college expects that these events will motivate those students intending to pursue careers that are considered unconventional and challenging.

Apart from the Law fest, various departments at Christ University conduct their own collegiate and inter-collegiate fest. School of Law is conceptualizing more inter-collegiate law fest and students are expected to contribute in this regard.

## 8. Sports and Games

Sports and games facilities are provided on campus in order to attain physical growth and nurture sportsman spirit among students. The University has separate courts for most major games like basketball, football, volleyball and hockey. ## 9. Infrastructure

#### **Campus**

The Bangalore Urban Art Commission has selected the college for the Best Campus Award for four consecutive years, 1996 through 2000. Well-maintained gardens and buildings, air-conditioned Seminar Halls, Panel Room, Conference Hall, Assembly Hall, Terrace Garden, Auditorium, Health Club, Kiosk and all the requirements of an institute of higher learning are the unique features of our college.

#### Library

The students of School of Law has access to three different library facilities namely the General Library; the specialized Law Library and the online library

The General Library comprises of 1,00,000 books and subscribes to 240 journals. The Library also has a good collection of audio and videotapes for use of faculty and students.

The School of Law Library has a collection of 12000 books on various legal subjects. The Library also has 5000 volumes of various reports. The All India Reporter, SCC, Criminal Law Journal, Labour Law Journal, Madras Law Journal, American Law Reports, The Law Reports, All England Law Reports etc etc. to name a few.

Online databases - Manupatra, Westlaw, Heinonline, EBSCO, JSTOR, SCC online, ICFAI and a monthly online commentary on Indian Economy through the Centre for Monitoring Indian Economy, are made available to students and faculty throughout the campus using wireless internet service.

The library information is computerized with OPAC terminals at various points in the Library and is open from 8 a.m. to 9.00 p.m.

#### **Computer Labs**

All administrative works of the University are computerized. The five computer labs are equipped with the 350 latest Intel microprocessor-based computers. The lab has 130 Pentium IV based nodes and core2duo each with 512 MB RAM, 256 MB RAM, 2GB RAM,160 GB and 40 GB local hard disk, CRT and TFT colour monitors connected to four Windows 2000 Servers and five LINUX Servers. Laser Printers, Inkjet Printers, Digitiser, LP 735 Data Projector, Scanner, Dot Matrix Printers and other peripherals are connected to the network.

#### **Internet Lab**

To integrate Information System Technology into the present curriculum, the college is one of the first educational institutions to be able to boast of Internet connectivity through 6 MBPS and 2 MBPS by Reliance and Airtel Internet leased line connecting its students to the world and beyond. The faculty and the students are encouraged and allowed to surf the net free of cost. All the departments are connected through the Internet, making way for easier access to information.

#### Canteen, Kiosk, Ivy Hall

The University provides a healthy environment in the cafeteria and makes sure that quality food is served at reasonable price. The food court, kiosks and Ivy hall help the students refresh themselves with snacks.

#### Health Club

Christ University has recently opened a Multi Gym and Fitness Centre for both students and faculty. The well-stocked gym consists of Multi Gym, Manual Walker, Excercycle and Weights. The gym also has an instructor who is an aerobic and martial art expert
